## PICUM/LOS/ROS Conference Criminalization illegal residence 27 May Rotterdam

The Dutch authorities intend to criminalize illegal residency. PICUM, the LOS foundation, the ROS foundation, and the Pauluskerk organize an international conference with the purpose of providing insight into the criminalization of illegal residence in other European countries. In this way we hope to be able to make a case against the plans of the Dutch authorities. The official language of the conference is English. You will find more information in the preliminary programme and on the registration form.

# 1. Basic rights

#### **Work placement MBO**

Ministers Kamp and Bijleveld have stated that MBO students without residence permits are not allowed to work and therefore are not allowed to participate in work placement programmes either. Previously other ministers had stated that students were entitled to participate in work placement programmes, because they have a right to education. As yet Defence for Children attempts to achieve the right to work placements.

#### Right to marry

The European Court of Human Rights have decided that marrying is a human right, which also applies to migrants who have no residence permit. Financial consequences are not allowed to provide an impediment.

# 2. Admission policy

## Female genital mutilation in Burkina Faso

Because of the risk of genital mutilation in Burkina Faso, it is mandatory to grant legal status to girls who have not undergone genital mutilation, according to the Court of Appeal Zwolle.

#### Single mother can be sent back to Iran

The Council of State, the Court of Higher Appeal, are of the opinion that in Iran the risk of persecution of single mothers who return to that country, is not grave enough to grant this group legal status.

## Pakistan does not protect the victims of honour-related violence

The Court of Appeal in Arnhem have decided that a Pakistani man who had been threatened with honour-related violence by his wife's relatives will not be protected by the Pakistani authorities and is therefore entitled to asylum.

#### Residency with Dutch children

Previously several Courts of Appeal had decided that it is in the interest of children with the Dutch nationality that their parents can join them in the Netherlands. The Court of Appeal have ruled that it is not mandatory for these parents to obtain an authorisation for temporary stay. These verdicts refer to the ruling of the European Court of Justice in the case Ruiz Zambrano of March of this year.

#### **Convention Council of Europe on domestic violence**

The Council of Europe have adopted a convention which condemns domestic violence. Victims should be protected, even if they have no residence permits.

#### No protection of victims of human trafficking in Nigeria

The Court of Appeal Assen have decided that the support of victims of human trafficking in Nigeria is inadequate. Victims are to be granted prolonged stay in the Netherlands.

# 3. Check and Deportation

## Criminalization illegal residency in breach of Return Directive

In Italy illegal residency has already been made liable to punishment. On 28 April the European Court of Justice decided that criminalization is in breach of the Return Directive. This directive stipulates which specific measures countries are allowed to take in order to stimulate migrants to return to their country of origin. These measures do not include imprisonment.

## **Check Chinese migrants**

The Immigration and Naturalisation Service and the Aliens Police co-operate in order to clamp down on human trafficking. They also monitor the abuse of applications for residence permits for education and work for Chinese migrants.
