### HEALTH CARE FOR UNDOCUMENTED MIGRANTS 2014

The Dutch Council for Quality of Health-care [Zorginstituut Nederland] issued the monitor Health-care for Uninsurable Migrants 2014. An amount of over 30 million euros was spent on health-care costs for undocumented migrants. Over half of this amount was spent on hospital costs; in addition 19% on mental health care and 13% on medication costs.

In 2016 the regulation Uninsurable Migrants will be transferred from the Dutch Council for Quality of Healthcare to the CAK.

The Care monitor further expands on the medication declarations. Over 7200 individual persons were given medical drugs. The costs can be broken up as follows:

## 1. BASIC RIGHTS

Council of State: birth certificate legalised by Afghan embassy can still be rejected by The Netherlands  
According to the Council of State the Afghan embassy is incapable of assessing whether Afghan birth certificates are genuine and therefore The Netherlands can consider these documents to be not genuine. You will find more information [here](#).

## 2. ADMISSION POLICY

Council of State: no risk of genital mutilation for Dutch child of Guinean mother  
According to the Council of State Dutch children cannot be included in their mothers' asylum applications. Therefore the mother cannot be granted an asylum permit because of the risk of genital mutilation of her daughter. You will find more information [here](#).

Court of Appeal: Guinean mother can protect her daughter from genital mutilation  
This mother lived in hiding in Guinea for a long time in order to protect her daughter from genital mutilation. According to the court of appeal this is acceptable for the future as well. In addition there are projects in Guinea to help mothers protect their daughters from genital mutilation (Court of Appeal Roermond, 15/6179, 15.10.15).

Council of State: au pair is work; as a consequence of the association treaty Turkish au pairs do not need an authorisation for temporary stay  
From the contracts of this au pair the Council of State have inferred that this au pair will work for 30 hours per week. As an employee the association treaty applies to this Turkish au pair (provision 1/80), which states that admission cannot be submitted to new conditions. Therefore an authorisation for temporary stay is not required. You will find more information [here](#).

## 3. CHECK AND DETENTION

Dienst Justitiele Inrichtingen [Office for Judicial Institutes]: no decrease in application of isolation in detention of aliens

According to psychologists isolation is a harsh measure, particularly for people with psychological problems. Last year the state secretary promised to place fewer people in isolation when they have been placed in detention of aliens. But statistics retrieved by *the Volkskrant* show that isolation (in proportion to the number of people in detention of aliens) has not decreased and that it was used as a measure of order relatively more often - in many cases this concerns people with psychological problems.
