OPPORTUNITIES FUND: ADDITIONAL MONEY FOR CORONA INITIATIVES

Because the situation is still dire, the Kansfonds [Opportunities Fund] has extended the emergency aid for homeless, undocumented migrants and people in destitution until the end of 2020. This aid includes living allowance, humane shelter and accommodation and food supply for these vulnerable groups. It is to be expected that this emergency aid will be continued in 2021.

Court of Appeal: risk of disproportional sentence on return Moroccan woman with extramarital child This case concerns a Moroccan woman who, in The Netherlands, gave birth to a child of a Syrian man. In Morocco extramarital sex is punished with a prison sentence. The court are of the opinion that this is a violation of the prohibition of inhumane treatment. Therefore she cannot be expelled. <u>Court of Appeal: status for Sudanese woman because of risk for repeated circumcision after</u> reconstructive surgery

This Sudanese woman who underwent reconstructive surgery after her circumcision has applied for asylum in The Netherlands. The IND has rejected her asylum application because the woman concerned is highly educated and in Sudan there is no risk of repeated circumcision for independent women. However, the lawyer has shown that women in similar situations have been granted asylum permits. This should therefore apply to this woman as well, according to the Court (Court of Appeal Amsterdam, NL20.6162 and NL20.7559, 5.10.20).

<u>Court of Appeal: 81-year-old mother should be admitted for visiting her daughter in The Netherlands</u>
The admission criteria for foreigners have been tightened due to corona. Therefore this 81-year-old woman from South Africa who wanted to visit her daughter in The Netherlands, was refused entry at the border. She was placed in a hotel and had to return.

The Court are of the opinion that the corona policy is European policy. In other countries relatives are admitted. Therefore this woman should not have been refused entry (Court of Appeal Haarlem, AWB 20/7449, 9.10.20).

CHECK AND DETENTION

Council of State: detention of aliens after regular home inspection is allowed

Currently this man is in aliensdetention with the intention to expel him. He stated that he should not have been arrested.

The Council of State has concluded that the police initially went to the address on account of complaints by the neighbours concerning neighbourly conflicts. Thereupon they checked the identity papers of the people present. In situations like these this is allowed. Therefore it was justified to place this man in detention of aliens.
