MIGRATION DEBATE: TOWARDS MORE LEGALE LABOUR MIGRATION?, 17 FEB 16 HRS

Over the past years, there were vast differences of opinion in the Netherlands about migration, including the labour migrants, who sometimes reside in the Netherlands without the required paperwork. For the 'Scaling Fences' study, irregular migrants from the whole of Europe were interviewed, revealing their motives and deliberations. Many of them show a striking determination, in spite of the stricter government policies in the last few years.

Recently, the points of view of the political parties have shifted: many of them, both left-wing and right-wing parties, mean to allow for more regulated labour migration. D66 and PvdA want to allow temporary labour migration, while PvdA sets out to compel countries to take back illegal migrants. CDA and GroenLinks aim to develop policies in a European context, and some smaller parties, such as SGP, likewise want to allow labour migration.

What reasons do CDA, D66, PvdA and Groen Links have? Which problems will be solved by the proposals and what issues are insoluble? Special attention will be paid to Rotterdam, national forerunner in thinking about immigration.

<u>Council of State: new asylum application following temporary status as a victim of human trafficking counts as renewed application</u>

Court: commencing date human trafficking policy Dublin claimants

As from 1 August 2019, victims of human trafficking who first entered another EU country (Dublin claimants) will only be granted a residence permit as victims if there are 'prospects of conviction' in the Netherlands. Since the start of 2019, the waiting period for reporting as a victim of human trafficking increased significantly. Many victims could not officially inform the police until months following their first report. The judge has now decided that the declaration date coincides with the commencing date of the new policy, rather than with the actual reporting date. See here (Dutch only).

Court: residence permit caring father of 15-year-old N child

Parents of Dutch children can be granted a residence permit if their residence in NL is required for caring for their Dutch child. In recent years, the criteria for this permit has become increasingly stricter, particularly for fathers and for older children.

In this case, the father had filed much evidence regarding his care responsibilities. The child needed special supervision, and the mother was unable to provide it. The child had been referred to special schooling. The school had supplied multiple statements. That is why the judge finds that this father must remain in the Netherlands. See here (Dutch only).

Court: full private life appraisal needed for rejecting children's pardon application

This family applied for a residence permit for the Final Regulation Children's Pardon. It was rejected, because the youngest child was fifteen at the time of the first asylum application and therefore did not reside in NL as a 5-year-old minor. However, the judge finds that a full appraisal must be made, weighing in, among others, the children's long residence in NL and sexual orientation (Rb Amsterdam, AWB 20/2737 and AWB 20/2738, 29.12.20)

CHECK AND DETENTION

Council of State: entry ban overstaying Brazil woman upon departure from Schiphol

This judgment reveals how a light entry ban is imposed upon return following illegal residence. This case concerns a Brazilian woman, who, following illegal residence, wanted to return to Brazil from Schiphol. In such cases an inquiry form in the native language is handed out at Schiphol. If the person concerned does not apply for an interview, a return decision and an entry ban intention is handed out.

The person concerned can respond to that intention at Schiphol, or upon arrival in the destination country. In that case, the procedure is completed 'in absentia'. The person concerned can also appeal against the entry ban from abroad.

This method has been used since September 2018, and hundreds of entry bans have been delivered in this way. The Council of State considers this method to be correct. See here (Dutch only).
