This notion ignores reality on different levels. Those involved in supporting people without a status think it's time to face this reality and to starting working on solutions. Looking away doesn't solve anything.

## **1. BASIC RIGHTS**

## ECSR: Freedom-restriction centre also for aliens during admission procedure

In November 2015, the Dutch Administrative High Court (CRvB) and the Council of State responded to the decision by the European Committee of Social Rights regarding the right to shelter, saying that the freedom-restriction centre (VBL) is the designated accommodation. This case concerns a man who is still in the process of awaiting a residence permit and who's been allowed to await a decision in the Netherlands. Nevertheless, the CRvB has decided he be accommodated in the VBL. Read <u>here</u> (Dutch only).

In another case, the Council of State has made clear that accommodation in the VBL is only vailable if someone is willing to cooperate towards their return. Read <u>here</u> (Dutch only).

Supreme Court: Dutch nationality for child that has only been acknowledged by father at adult age This case concerns the child of a Dutch father in Australia, that grows up with both parents as a family, even though the father is formally married to someone else. The Supreme Court has decided that in the Netherlands, this situation would result in parentage, and thus that the child has been a Dutch national from birth. Read <u>here</u> (Dutch only).

<u>Council of state: Bill of Divorcement is needed for registration Liberian divorce in NL</u> In Liberia, the wedding has been performed traditionally. The Certificate of Divorce has not been appended by an apostil or legalisation, but by a Notary Certificate. The Council of State has decided that this is insufficient according to Liberian law and refuses registration. Read <u>here</u> (Dutch only).

## **2.** ADMISSION POLICY

<u>State secretary Security & Justice: extension moratorium on decisions for Yemen</u> The moratorium on decisions and departures for aliens from the Yemen will be extended by six months, until 13 August 2016. The reason is that the situation is still very insecure. Decisions are suspended and Yemenites will be accommodated. Read <u>here</u> (Dutch only).

<u>Court: request of Central Authority needed for placing as a Moroccan foster child</u> For more than two years, this Moroccan child has been cared for financially and emotionally by the foster parents who are living in the Netherlands. They want to invite the child to NL. The judge has

decided that a formal request of the Moroccan Central Authority regarding Children's Issues is needed, as well as a report on the necessity. They are lacking in this case. Read <u>here</u> (Dutch only).

## Court: no residence with child as Somali nationality is not certain

This man has requested residence with his child, which has been placed under supervision. He has resided in the Netherlands illegally for 17 years. The judge has rejected his request, as he cannot prove his Somali nationality (VK Rotterdam court (mk), AWB 15/2205, 28.1.16).

Court: decision commencing date EU citizenship only feasible when necessary

The judge has decided that the EU citizenship will be granted without any application, as soon as the conditions are met. Thus, it's not possible to ascertain the starting date. Sometimes the commencing

date is relevant, for instance for the long-term residence after 5 years and for a decision on the consequences of using social security. The commencing state must be decided in a procedure about the consequences, the court has decided (VK Amsterdam court (mk), AWB 15/8320, 2.2.16)

<u>Council of State: psychological problems children demand special assessment framework</u> Centrum 45 has issued a report regarding the psychological problems of children, detailing the differences with adults. However, the BMA, IND's medical department, has not taken these into account when it assessed the psychological problems of the children. The judge has decided that the BMA needs to write a new report. Read <u>here (Dutch only)</u>.
