# HVO-QUERIDO / COMENSHA: EXPERT MEETING HUMAN TRAFFICKING, 4 DEC

On 4 December, HVO-Querido and Comensha will jointly hold an expert meeting on recognising and supporting victims of human trafficking.

It is not always easy to recognise signals of victimhood. How can this be improved? And where can you go once you have come into contact with a potential victim? How can victims receive the help they are entitled to? And how do you discuss the future with your clients, especially if the chances of a permanent residence permit look slim? How do you enter the discussion in such a way that the client's rights and interests come first? And how can you do so in time, so that all options are still open for discussion?

On December 4, these and other questions will be discussed. The starting point of the meeting is the participants' expertise and their willingness to actively enter discussion about the above-mentioned questions. In the afternoon, there is ample opportunity to find out more about the training programme that has been developed regarding these topics.

# 1. BASIC RIGHTS

<u>Dutch GP Association: from 1 January 2018 more hospitals contracted to help uninsurable aliens</u>
From 1 January 2018, new hospitals can enter into an agreement with CAK for the funding of care given to uninsurable aliens. The list is likely to be extended.

Court: Children of Surinamese Dutch nationals born between 1975-1980 are Dutch

By means of the State Ordinance for the Regulation of the Surinamese Nationality and Residence agreed between the Netherlands and Suriname it was established who was granted Surinamese nationality. Children are given their father's nationality. However, this does not include children who were born after the state ordinance came into force in 1975. If the child was born after 1975 and before the father was given Surinamese nationality, it has Dutch nationality. See <a href="here">here</a> (Dutch only).

<u>Court:</u> Revoking Dutch nationality correct, since Ghanaian nationality was not given up Upon becoming a Dutch citizen, this Ghanaian man promised to give up his Ghanaian nationality. However, despite judicial demands, he turns out not to have done so. That is why Dutch nationality is revoked. The judge is in agreement. See here (Dutch only).

## 2. ADMISSION POLICY

IND: online application for residence permit for child of legal parents

Parents can now apply for a residence permit for their child on the IND website, see here (Dutch only).

Court: examine domestic violence and daughter's needs prior to continued residence decision. This case concerns the application for continued residence on account of domestic violence. De Immigration and Naturalisation Service (IND) had doubts about the domestic violence. The applicant submitted a 'Veilig Thuis' report as evidence. This report states that a consultation took place in the town hall, involving various social institutions, including the police, to talk about the unstable domestic situation. During the consultation, the police affirmed that there is domestic violence in the form of verbal violence. Moreover, a statement by acquaintances was submitted in which they state that they witnessed verbally aggressive behaviour by the husband. Lastly, various institutions are involved assistance to the daughter, which is also documented. On account of all this information the judge finds that rejection of the application for continued residence is insufficiently motivated. See <a href="here">here</a> (Dutch only).

Court: individual income assessment obligatory/interest NL child pertinent if application made abroad This case makes clear that for each application for residence with partner, an individual income assessment is obligatory. Moreover, it becomes clear that the right of a Dutch child to the care of a parent is pertinent to the application for a provisional residence permit (mvv) if one of the parents is still abroad. Court: status 'humanitarian' following 3-yr status as victim of human trafficking It becomes clear from this case that, following a three-year permit as a victim of human trafficking, the right to a permit for continued residence is upheld. The three-year period does not need to be continuous. See <a href="here">here</a> (Dutch only).

## 3. CHECK AND DETENTION

### Court: punishment for helping undocumented resident

This case concerns an agricultural company, where an undocumented Moroccan man lodged and worked for (low) wages. The situation came to light following an accident. the works manager was condemned to 2 months' detention and a € 20,000 fine. The employee is still due back pay amounting to more than € 11,000. The judge acknowledges the situation was meant to help out, but also wants to make an example. See <a href="here">here</a> (Dutch only).

#### Court: Possibly scope to renewed deportations to China

Since 2015, it is assumed that China does not participate in deportations. The Repatriation and Departure Service (DT&V) has stated that a Chinese delegation recently visited the Netherlands to discuss issuing Laissez-Passers (replacement travel documents) for deportations. That is why this Chinese woman has been allowed to remain in alien detention. If the delegation proves unsuccessful, she must be released. See <a href="here">here</a> (Dutch only).
