LIBE-STUDY: THE FUNDAMENTAL RIGHTS OF IRREGULAR MIGRANT WORKERS IN THE EU - UNDERSTANDING AND REDUCING PROTECTION GAPS

This study aims to inform policy debates about how to protect more effectively the fundamental rights of irregular migrant workers in the EU. It analyses the nature and causes of the gaps between the fundamental rights protections enshrined in EU legal standards and the rights realised by irregular migrants working in EU Member States in practice, and it discusses strategies for how these 'protection gaps' can be reduced.

Court: after divorce, women in Iran at risk of honour-related violence

This case was about a divorced Iranian woman who survived an acid attack by her ex-husband but did not dare report it to the police. The judge found that the IND should take more account of the risk of honour-related violence faced by divorced women. The justice system in Iran offers women little voice, and so little protection. Training: digital storytelling, 27-28 Aug, Amsterdam

The European Digimi project aims to make newcomers feel more at home in their new surroundings through (digital) storytelling. One of the focal points is connecting different groups in society. To achieve this, in the last two years they have worked on a method and a web app that can be used to facilitate discussion between people and allow them to share their stories.

This method and web app are also the basis of this training for trainers. In this two-day training course, you will acquire more knowledge of and experience in working with (digital) stories. Furthermore, we will look at how you can work with different groups and how you can connect people. You can put the skills you acquire to use three weeks later, during the Digimi Event, Meeting each other in stories and film, which is taking place in Amsterdam on 18 September.

European Parliament paves the way towards recognition of Domestic Workers in Europe

T he European Parliament in Plenary adopted a resolution Towards a common European action on care, an important step forward towards the value, recognition and professionalisation of the domestic sector in Europe.

The report also calls on Member states to ratify and implement ILO Convention 189 concerning decent work for domestic workers and no. 190 on violence and harassment in the world of work. See <u>here</u>
