OPENING EXPOSITIE ONGEDOCUMENTEERD EN OP LEEFTIJD, 15FEB A'DAM

On Thursday 15 February 2024 at 15:00 hrs, in the *Mozes en Aäronkerk* church in Amsterdam, theatre, movie and television maker Nora Akacher will open the exposition 'undocumented and elderly', which contains photographs by Mona van den Berg.

Photographer Mona van den Berg followed 23 people who had been living in the Netherlands for decades, but never obtained a residence permit. By giving them a face, we are given an impression of their lives that are normally hidden from sight.

BASIC RIGHTS

<u>Dutch Tax Department: no single-parent additional allowance ('ALO-kop') but also no repayment demand</u> for parents with a partner without a BSN number

Persons who have a partner without a BSN number or a partner living abroad are each other's allowance partners. This results in some cases in persons with a partner abroad or a partner who follows later to the Netherlands wrongly receiving an 'ALO-kop' (i.e. single-parent additional allowance) which must later be repaid.

To prevent high recovery amounts, the tax department's 'allowances office' (*Dienst Toeslagen*) decided in 2023 that recovery of child allowance is undesirable if applicants had already reported their marriage to the municipality but this had not been entered into the systems of the allowances office. In those cases, the partner of applicant will only be taken into account from the moment of processing in the allowances system instead of retroactively, as was customary before. In addition, a process will be set up to periodically use data from the BRP to determine the possible presence of an allowance partner. To avoid a repayment demand in the future, these individuals can register marital status with the municipality, communicate in the allowances portal that there is a partner and can apply for a bsn for this partner.

ADMISSION POLICY

District Court: stay of elderly mother at daughter in the Netherlands

In two different cases, the court ruled that the IND must carefully weigh all interests in the case of an elderly mother who needed informal care from her daughter in the Netherlands. There was no longer a safety net in her home country. In both cases, the application was submitted after the mother had travelled to NL for family visits.

This case is about an 88-year-old South African mother suffering from Alzheimer's disease.

This <u>case</u> is about an 85-year-old Ukrainian mother with geriatric complaints.

Pauluskerk Rotterdam: shelter for the undocumented elderly.

ASKV Refugee Support: 'Statelessness in the Netherlands'
