#### Court of Appeal: Chavez status is possible in the case of care for Dutch stepchildren as well

This ruling has shown that a partner who acts as carer although he is not the legal father of the children can obtain right of residence as custodial parent. In this case the legal father was still in the Netherlands but he was no longer in contact with his child. The caring partner has taken emotional as well as financial care of the Dutch child. The Court concludes that in this case there is a relationship of dependency as indicated in the ruling Chavez-Vilchez. You will find more information <a href="here">here</a>.

#### Criteria for readmission Surinamese people who formerly had Dutch nationality

Elderly Surinamese people who were born with the Dutch nationality and who reside in the Netherlands without a residence permit have submitted a request for 'readmission'. If you know people who meet these criteria, you can report this <a href="here">here</a>.

In reply to parliamentary questions concerning this procedure the Secretary of State explained what the formal criteria for readmission are. Concerning this especially the ties with the Netherlands are of importance. According to the Secretary of State illegal stay in the Netherlands in itself does not count. ## **CHECK AND DETENTION**

#### Court of Appeal: insufficient basis for check Brazilian Uber drivers

According to the Aliens Police there are many Brazilians without a residence permit who work as Uber drivers. Therefore, the police had started to check this group. Uber drivers without a residence permit have been placed in detention of aliens.

The Court are of the opinion that arresting cyclists with an Uber bag, on the basis that they may not have a residence permit, is arbitrariness. This is only allowed if there is sufficient evidence of illegal work. The drivers in detention must be released. You will find more information here.
